Describe the role of medications (methadone and buprenorphine) in reversing the opioid epidemic.

11:10am Collaborative Treatments that Work and the Neurobiology Behind Them

Discuss the basic elements of drive and cognition in the neurobiology of addiction. List three safe and effective psychosocial interventions for the treatment of opioid use disorders. Discuss the link between interoception and mindfulness. Discuss clinical collaboration and team-based best practice in opioid treatment.

12:00pm Panel Discussion: Interprofessional Perspectives on the Current Opioid Crisis

Panelists: Dr. Glenn J. Treisman / Dr. Hillary Kunins / Dr. Petros Levounis

Discuss various recommendations for strengthening collaborative efforts to combat the opioid epidemic. Concept to Psychobiosocial Process; From Abstinence-Only to Integrative Harm Reduction Treatment

Define the psychobiosocial process model of SUDs as reflecting an interaction of psychological, biological and social factors that are unique to each person. Identify challenges and recommendations for bridging the professional divide and strengthening collaboration between abstinence-only and harm reduction communities.

Describe the benefits of interprofessional community coalitions in mobilizing against opioid use disorder. Explain the goals of treatment courts and key components of drug courts in addressing opioid use disorder. Describe multiple methods of engaging with health care systems and health care professionals to improve care for patients with opioid use disorder.

3:45pm New Trends in Substance Use in the Current Public Health Crisis: Keys to Engaging the Active Substance User

Steve Chassman, L.C.S.W., C.A.S.A.C.

Identify current trends in drug use. Identify evidence-based practices for engaging young people including Motivational Interviewing and Stages of Change. Describe ways to motivate adolescence and tips for working with people who use. Describe the importance of educating clients, family, community and other healthcare professionals specific to trending drugs of use, drug addiction, treatment and related support resources. Describe the importance of collaboration across healthcare and other professions in decreasing the harmful effects of drug addiction and overdoses, and improving overall health outcomes.
