SB728: Access to Care & SB778/HB1035: Healthy Babies Equity Act

Sponsors: Delegate Pena-Melnyk & Senator Lam

HB6/SB150: MD Medical Assistance Program – Dental Coverage for Adults

Sponsors: Delegate Cullison & Senators Augustine, Guzzone

HB709/SB632: Small Business and Nonprofits Health Insurance Subsidies Program

Sponsors: Delegates R. Lewis, Lierman, Lewis Young & Senators Hester and Feldman

Requires the state to commit \$45 million/year to help small businesses and small nonprofits pay for health insurance for workers at Maryland Health Connection through a state subsidy program, plus \$3 million/year for outreach. SB761: Maryland Medicaid Wage Pass-Through Act

Sponsors: Delegate Young & Senator Rosapepe

HB694: Justice for Hospital Patients Act of 2022

Sponsors: Delegate Charkoudian & Senator Hayes

Requires the Office of the Comptroller, the Department of Human Services, and the Health Services Cost Review Commission to help identify and notify low-income hospital patients who should have received free care that they are entitled to reimbursement from the hospital for overpayment of medical expenses. HB8/SB275: Time to Care Act of 2022

Sponsors: Delegate Valderrama & Senator Hayes

Establishes a family and medical leave insurance program, through which employees may take up to 12 weeks of paid leave to care for new children, other family members with severe health conditions or disabilities, or themselves. Pregnant Person's Freedom Act

Sponsors: Delegate Williams & Senator Smith

Prohibits the subjection of pregnant people or those who have experienced pregnancy loss or termination to Maryland's criminal justice and/or civil court systems.
